ANNAPOLIS FRIENDS MONTHLY MEETING- MEETING FOR WORSHIP WITH ATTENTION TO BUSINESS

Seventh Day of the Eleventh Month 2010

Barbara Thomas (Clerk), Marcia V. Ormsby (Recording Clerk) and 21 other Friends and attenders present. Our Meeting began with centering worship.

**Nominating Committee:** Leo P. reporting: The Committee will meet this Second Day, at 6:30pm at the Meetinghouse; the members of this committee were announced. The 2011 List of Committees, Officers and Representatives was distributed and is attached to these minutes; questions were asked and answered. Many Committees will be overseeing sub-committees for oversight and support; these representatives are invited to become part of their assigned overseeing Committee. Peace & Social Concerns Committee has been selected to offer an umbrella to our Representatives to groups serving outside our Meeting. Ministry & Worship Committee will also oversee Representatives as listed. A plea was made for more people to step forward to join the CREC Committee and to provide Nursery Care. We have been asked to recognize our growth and members' needs to serve or not to serve. All interested and those with suggestions are encouraged to be in touch with Nominating Committee members prior to the end of the year.

**Stewardship & Finance Committee:** Barbara T. reporting for Mary K.: The proposed budget has been sent through the announce list and extra copies are available. The specifics of the dollar amounts will be determined at the 12<sup>th</sup> Month Meeting for Worship with Attention to Business. The line item from last month's report of unrestricted donations is noted to be increased from \$38K to \$40K. The \$10K to be assigned to the building committee will be added to the general budget of the Meeting. Several funds have been decreased to reflect the decrease in contributions. The details of the specific amounts increased, decreased and retained will be specified following next month's report. It was suggested that the speakers' fees, and honoraria be retained under their specific committees. Stewardship and Finance will offer a threshing session 01-23-11 to prepare a balanced budget. All are encouraged to attend this important meeting.

**Baltimore Yearly Meeting Interim Report:** Pat S. reporting: The Interim Meeting held Tenth Month 16<sup>th</sup> 2010, in Richmond, Virginia, was attended by three Annapolis Friends. Friends found unity with a Minute offered by the Indian Affairs Committee in support of U.S. ratification of the U.N. Declaration on the Rights of Indigenous Peoples. This Minute had been offered at the summer session in Eighth Month, 2010 and held over for consideration at the Interim Meeting. The U.N. Declaration has been passed by all the nations of the U.N. with the exception of the U.S. and Canada. It guarantees to indigenous peoples, self-determination; rights to land, territories and resources; cultural integrity; and respect for existing treaty rights. BYM agreed to begin paying dues to Friends United Meeting, following several years of withholding, because of FUM's hiring policy, refusing gay Friends. Inter-visitation among and between liberal and conservative Meetings, were remarkable for breaking down barriers on the issue of gay rights. BYM Friends visited almost all United States FUM Meetings; Friends from Midwestern FUM Meetings and have been present at all BYM annual sessions for several years. While the FUM personnel policy has not changed, BYM has generated a fresh perspective to this issue. Most gay Friends present took a lead in supporting resumption of the payment of dues.

**CREC:** Carin K. reporting: In the past, AFM has contributed to families in need around the Thanksgiving and Christmas holidays. This year we cannot take on this effort, but perhaps another committee would like to help, or another method could be developed to offer food to those many families in need. Friends are reminded that many of our resources are being donated to the Lighthouse Shelter, which may supplant these Holiday Giving Efforts. We note gratitude to CREC for its prior contributions.

Finally a Pot Luck will celebrate our new children and their families. We hope many of you will come and celebrate our families.

4) **Stone Soup Sharing:** Please mark your calendars to join us on 21 November as we gather at rise of Meeting to celebrate Thanksgiving, simplicity, and our community, with a reading of the book 'Stone Soup' by John Muth. Enjoyment of a simple lunch of 'stone soup' and rolls, will accompany an opportunity to learn how to make the beautiful mandalas the children will be offering for sale at holiday market. If you would like to contribute a cup of cut up vegetables to our community soup, you may drop it off in the kitchen any time before 11 am.

5) **Radical Hospitality Workshop:** Great appreciation was mentioned for our 11-6 Seventh Day Meeting's all day workshop presented by Brad O. from the William Penn House.

**Save Darfur Coalition:** Sylvia O. reporting: "The Save Darfur Coalition and Genocide Intervention Network, two organizations that have been working together for years to stop the genocide in Darfur, have merged as of 11-1-10. The aim of the merger is to increase our powerful voice both for preventing and ending genocide in the world. In January 2011, Southern Sudan will have a referendum to decide if it will secede from the North. In view of this 'tinder-box' time, when violence threatens to erupt again, various bills have been presented in Congress. I urge that Friends, as individuals, contact their Senators and ask them to cosponsor S. Con. Res. 71, the Senate resolution to increase U.S. civilian capacities for the prevention of genocide and mass atrocities. Both FCNL and the Save Darfur Coalition support this legislation."

**The time we have waited for ALL YEAR is almost here! HOLIDAY MARKET TIME!! Mark your calendars for Saturday December 4th from 9:00 to 2:00.**

**As in the past, 75% of our market proceeds will support a nonprofit organization outside of our Annapolis Friends Meeting and 25% will support the work and needs of our own meeting. The 75% this time will support the work of Women for Afghan Women and directed to the Afghan Women's Fund that focuses on literacy for women and girls. Fahima Vorgetts has worked diligently to build schools and provide vocational training opportunities in Afghanistan. She has participated in many of our past holiday markets by selling rugs, jewelry and other items made by women in Afghanistan. Of the 25% of proceeds, \$100 will be given to the Children's Religious Education Committee to allow the children to choose the work and charity or charities they want to support. The children have been a very active part of this market and have made many items to sell. This contribution is in honor of their energy and leadings to be in mission. \$150 will be used to purchase 3 additional long white tables for the meeting house; and the remainder will be given to the Peace and Justice Center.**

**We are excited about offering again some special treats like the paperwhite bulbs, the fresh greenery arrangements, brand new books from FGC, and the now-famous Quaker bean soup mixes. In addition we are debuting the Quaker Qafe which will feature crepes (a la chef Douglas) and a variety of homemade soups and bread with specialty butters; the children's handmade crafts, and an expanded boutique of new and gently used fine clothing. So please begin setting aside those gently-used, look-like-new housewares, jewelry, clothes (especially holiday and professional), books, toys, electronics, sports equipment and more, (no furniture please).**

**THINKING ABOUT RACE** (December 2010) - From an email received in October from Fred Baldwin, Carlisle Friends Meeting, expressing some thoughts regarding school choice and how he feels that it relates to race : “I am convinced that Friends collectively are following a ‘tinfoil rule’ -- all shine with no weight or substance. Defining racism almost exclusively as a personal matter gets us off the hook for institutional racism, most obviously in public education. Quakers, who led the fight against slavery, look to be in the rear guard (if not actually the opposition) on treating urban black children as deserving of the same opportunities as white families who can afford to live in good school districts. Honest people can disagree about how to achieve more [school] choice, but I think failure to focus on the issue is one of our gravest sins of omission.”

The Baltimore Yearly Meeting Working Group on Racism takes no position on this concern but welcomes your thinking. Friends may comment on this or any other “Thinking About Race” items, at <http://racismwg.bym-rsf.net>. First register at [webmanager@bym-rsf.net](mailto:webmanager@bym-rsf.net).
