POPLAR RIDGE MONTHLY MEETING FOR BUSINESS MINUTES FOR MAY 22, 2016

The Monthly Meeting opened with a period of worship about 12:40 p.m.; the minutes from the April 2016 meeting were read.

Attending were Larry Buffam, David Connelly, Anne Dalton, Barry Kahn, Cathy Mullarney, Suzanne O'Hara, Dill Otis, Sally Otis, Andrew Simkin, Jane Simkin, and Paul Simkin.

Based on information from Spring Gathering, Monthly Meeting approved of the change of a line of a memorial minute about Bill Simms. It now reads: "On the day he died, he had served 43 years of a 25-years-to-life sentence."

Larry Buffam asked that the two youths planning to be part of the annual trip to Salvador be funded by the Houck Youth Fund. Monthly Meeting approved using the fund to cover the cost of the tickets up to \$1,800 total.

Monthly Meeting approved the following Minute:

"Harriet Tubman is remembered for her accomplishments in leading enslaved African Americans to freedom via the Underground Railroad and promoting the abolition of slavery. Her cause held deep significance for many Quakers in Harriet Tubman's time. In Central New York, many Quakers advocated for abolition and helped in the Underground Railroad. Equality of all persons remains a vital testimony for Quakers today. As the Quaker Monthly Meeting geographically nearest Harriet Tubman's historical home in Auburn, N.Y., the Poplar Ridge Friends Meeting is pleased to celebrate the establishment of a new National Historical Park honoring Harriet Tubman's life and work. We also celebrate the recent announcement that Harriet Tubman's image will appear on U.S. currency. We continue to draw inspiration from Harriet Tubman's example and hope these acknowledgements of her actions will help bring healing in our nation's continued struggle with racism and the poisonous legacy of institutional slavery."

We will disseminate this Minute by mail to the clerks of meetings in our region, by email to the regional Quaker list-serve, and to the editor of the Auburn Citizen.

Larry Buffam of the Building Committee updated the Monthly Meeting on progress for improving insulation in the Meetinghouse's basement. The Committee is still gathering information on the project, which includes improving the heating systems. The committee continues investigating wall waterproofing and insulation, framing, dry-walling, spackling and painting the walls, electrical, and installing new windows. Current estimates, excluding heating, are \$7,000 to \$11,000: \$1,900 for foam insulation, \$1,000 for framing and drywall, \$1,000 for kitchen insulation, and \$3,000 to \$7,000 for windows.

Monthly Meeting approved using up \$10,000 of a combination of our resources, to be determined by the Finance Committee, for the drywall, insulation, and windows basement project as it continues planning for additional Meetinghouse structural improvements.

Dill Otis reporting for the Ministry and Counsel Committee that it has approved him as Clerk of the Committee.

The New York Yearly Meeting is requesting Monthly Meetings to respond to the Brooklyn Monthly Meeting's minute about FUM's personnel policy. To help our Monthly Meeting submit a response, Suzanne O'Hara will circulate links to the Brooklyn minute and relevant documents about FUM's policy. (*Editor's Note: These documents are included in this PRISM.*)

Barry Kahn requested that Monthly Meeting reconsider PRISM's publication policy. Anne Dalton reported that the entire PRISM policy is on the Outreach Committee's agenda for its meeting this week.



AIDS FOR MEETING DISCERNMENT REGARDING FUM PERSONNEL POLICY

Our Meeting has received a letter from the New York Yearly Meeting (NYYM) Nurture Coordinating Committee asking for input on the issue of the FUM personnel policy and the overall sense of our Meeting on sexual ethics. This letter, along with supporting documents both from NYYM and Poplar Ridge, are included in this PRISM. Readers can follow the links to read longer reports. Dear Friend

... In November, 2015, Nurture Coordinating Committee (NCC) sent a letter to monthly meetings asking them to consider a minute from Brooklyn Meeting regarding New York Yearly Meeting's relationship with Friends United Meeting (FUM) (see attached). ... Several meetings also have approached our representatives to the FUM board for more information. Those representatives alerted NCC to the fact that some potentially useful background information had not been provided with the November letter. I have attached two documents and provided links below to other documents that should provide a fuller context for your meeting's deliberations. You can find all of these documents, as well as other resources on the matter of FUM's personnel policy, on the yearly meeting's website <http://www.nyy.org/?q=FUMPersonnelPolicy>.

We bring your attention specifically to the following:

- The text of the minute of conscience from Brooklyn Meeting, as part of a report from Nurture Coordinating Committee to New York Yearly Meeting Summer Sessions, 2015 (attached).
- FUM's personnel policy (attached).
- Text of a statement from New York Yearly Meeting's FUM Task Group affirming our welcome of all individuals, regardless of sexual orientation, presented in the context of the relevant minute from

Yearly Meeting Summer Sessions 2009, which was subsequently distributed to local meetings, though not formally adopted by the Yearly Meeting (see the item at the end of this letter).

- A report by Carol Holmes, former representative to the FUM General Board from NYYM, offering a timeline of crisis points for FUM, its personnel policy, and its theological diversity covering the period 1988 to 1998 [<http://www.nyym.org/sites/default/files/TimelineofCrisisPoints-FUM.pdf>]
- A report from our FUM representatives to the April, 2007 Spring Sessions of NYYM touching on FUM's personnel policy and NYYM's affiliation with FUM [<http://www.nyym.org/sites/default/files/FUMRepsReport-April2007.pdf>].
- A brief update from Christopher Sammond, who is one of our representatives to the FUM board, about changes he has witnessed since that 2007 report [http://www.nyym.org/sites/default/files/Report-ChangesInFUM_03-30-16.pdf].

The minute that Brooklyn Meeting sent to New York Yearly Meeting asked NYYM to send a letter to FUM objecting to the discriminatory nature of their personnel policy, and asked the Yearly Meeting to only give funds to FUM for designated projects until such time as FUM changes its policy.

When Nurture Coordinating Committee reviewed the responses from monthly meetings at our meeting during Coordinating Weekend in January 2016, we felt that it would be important to reflect on the deeper issues raised by FUM's personnel policy: What does it mean for us to be a member of larger Quaker organizations? Should NYYM stay engaged with a Quaker organization that continues to hold policies that discriminate against individuals? If so, what should the nature of that relationship be? As a yearly meeting, is it incumbent upon us to discern our own sexual ethic, rather than only to critique another Quaker organization's attempt to do so?

If your meeting has already considered the matter of the Brooklyn Meeting's request of the yearly meeting and sent its response to Deb Wood, thank you. We encourage other meetings to spend some time considering the queries we ask directly above, as well. Nurture Coordinating Committee would like to be able to bring this matter to Summer Sessions in July, 2016.

NURTURE COORDINATING COMMITTEE REPORT TO NYYM SESSION JULY 24, 2015

At its meeting during Fall Sessions 2014, Nurture Coordinating Committee received the following minute from Brooklyn Meeting:

Brooklyn Monthly Meeting urges that New York Yearly Meeting (“NYYM”) follow the example of Canadian Yearly Meeting and draft a letter to Friends United Meeting (“FUM”) expressing displeasure at its current discrimination against LGBT Quakers in paid and unpaid positions of service or leadership. The letter to further state that until such time as such policies are laid aside and equally embraced for all Quakers, it will only designate its payments to FUM for specific projects, such projects which in the opinion of New York Yearly Meeting are worthy enough to exceed the damage to Equality and human dignity done by FUM’s discriminatory personnel policies.


At such time that New York Yearly Meeting undertakes such designation of its payments to FUM, Brooklyn Monthly Meeting will cease its present withholding of a portion of its Covenant Donation to NYYM in protest of FUM’s discriminatory personnel policies.

Nurture Coordinating Committee sent a letter to Brooklyn Meeting thanking them for raising the concern. NCC asked that the minute be seasoned by New York Quarterly Meeting before bringing it to the Yearly Meeting body. This happened on Saturday, July 18.

The letter also said that some of our representatives to the FUM General Board would be in touch with the meeting. Christopher Sammond has spoken with the clerk of Brooklyn Meeting, and more dialogue may take place. At the NCC meeting on Tuesday, July 21, Colin Saxton, General Secretary of Friends United Meeting, attended and also indicated a willingness to meet with Brooklyn Meeting.

Today, Nurture Coordinating Committee approved asking the Yearly Meeting office to send to all monthly meetings a memo that includes the Brooklyn minute, the New York Quarterly Meeting endorsement, the wording of the FUM personnel policy in question, the historical connection between NYYM and FUM, and some of the NCC minutes of our discernment on Tuesday. The content of the cover memo would be vetted and approved by NCC electronically before distribution. We hope to be able to accomplish this before Fall Sessions. Other ways of moving forward were considered, and will be considered further at Fall Sessions.

I ask that Friends who feel led to engage with this issue be in touch with me to explore possibilities.

STAFFING POLICY - FRIENDS UNITED MEETING

FUM presently has a hiring policy that requires all potential employees to sign a statement that affirms their commitment to confine sex to marriage between one man and one woman (i.e., heterosexual and nonpolygamous). FUM is seeking a way forward regarding this policy, given the wide diversity among its constituent yearly meetings—one of which now represents Friends who live in a country that recognizes gay marriage (Canadian Yearly Meeting) and others of which struggle with pockets of polygamous marriages among their members (the African yearly meetings).

The original link to FUM's employment application form posted on the FUM website that includes the following statement:

"Friends United Meeting affirms the civil rights of all people. Staff and volunteer appointments and promotions are made without regard to sex, race, national origin, age, physical disability (when not directly related to job responsibilities or when reasonable accommodation can be made), or sexual orientation. It is expected that intimate sexual behavior should be confined to marriage, understood to be between one man and one woman. "

Note that, when the webmaster revised NYYM web pages in the section of our website concerned with FUM's personnel policy (March 10, 2016), FUM's website was under construction and this form was no longer available. (http://www.nyyym.org/?q=genderstatement_fum)

MINUTE ON SEXUAL ORIENTATION - POPLAR RIDGE MONTHLY MEETING

The following minute was forwarded to NYYM from Farmington-Scipio Regional Meeting for consideration:

"Our experience has been that spiritual gifts are not distributed with regard to sexual orientation or gender identity. Our experience has been that our Gatherings and Central Committee work have been immeasurably enriched over the years by the full participation and Spirit-guided leadership of gay, lesbian, bisexual, transgender, and queer Friends. We will never go back to silencing those voices or suppressing those gifts. Our experience confirms that we are all equal before God, as God made us, and we feel blessed to be engaged in the work of FGC together."

Poplar Ridge approved the following minute, forwarded it to Fall Gathering where it was on the agenda but deferred, and would still like to have it considered by Farmington-Scipio Regional Meeting.

While we cannot speak for the experience of Friends General Conference Central Committee, we agree that spiritual gifts are not distributed with regard to sexual orientation and gender identity, and we affirm that we are all equal before God. Our Quaker testimony guides us to an all-embracing practice of human equality.

Dear Friends,



We received your requests for funds to support the future of Friends United Meeting as well as for this year's Chain of Prayer.
