

## MINUTES OF THE MONTHLY MEETING FOR WORSHIP WITH ATTENTION TO BUSINESS 15th day of Fourth Month, 2018

The Spring Friends Monthly Meeting for Worship With Attention to Business met for a shared breakfast and business at 9:30am in the Fellowship Hall on the 15th day of the Fourth Month, 2018. Elizabeth Osborne, Clerk, opened with a reading about the sense of the meeting in Quaker Business Sessions.

The minutes of Second Month were read by Judith Bush, acting Recording Clerk, and approved with one small correction. The Treasurer reported on finance through third month, which report is attached.

Chuck Fager reported that the Snow Camp Drama community has deferred the 2018 season until 2019 to reorganize and to develop the financial wherewithal to carry forward.

The Meeting was pleased to have received a warm letter from Palo Alto Friends Meeting concerning the Transfer of Membership for Judith Bush. Friends were pleased to accept Judith's Transfer and the Right Hand of Fellowship will be extended in worship in the near future.

Ronald Osborne reported from the Finance Committee Meeting earlier in the day. He received a proposal from Rhino-Shield, a specialized painting company, to repaint the Meetinghouse. This proposal was attractive as the company guarantees their work under a decreasing warranty. Friends agreed to proceed with this work.

Grim Hobbs updated the Meeting on the proposed Hut Addition, which includes building handicapped accessible bathrooms, a protective area over the front door, re-grading and

improved drainage for the area between the Meetinghouse and Hut, new roofing to match the Meetinghouse, and siding on the Hut. The current quote from contractors needs more specificity, and Friends agreed that the plan needs to be simple in keeping with our testimonies.

Friends agreed that another estimate would be prudent, with a greater breakdown of the pricing so that the Meeting could assess Needs vs Wants. The legacy of the building was discussed with thoughts about our responsibility to carry that legacy forward. Possible interpretations of financial data were discussed in light of the Ed McBane Piedmont Natural Gas stock being bought out by Duke Energy.

After discussion on the financial topics and our community commitments, the Meeting decided to let this matter season until Monthly Meeting in the Fifth Month.

The Meeting adjourned as the Worship Hour approached.
